fss inclusion top up grant – support criteria



In line with our Memorandum of Understanding on diversity & inclusion, EFP supports a diverse, multicultural and inclusive society, free of discrimination based on age, appearance, disability, gender, skin color, origin, religion or ideology, sexual identity or socio-economic status. Through a new Top Up Grant, EFP aims to encourage sales companies to invest more in the promotion of films depicting gender balance, equity and inclusion. For these campaigns, the maximum available grant per campaign can be topped up by €500 (calculated in proportion to the total expenses). Provided that sufficient budget is available, the Top Up Grant is available at ALL selected film festivals and markets. The final selection is made by EFP based on the list of criteria in accordance with the respective national film promotion institute.

Support Criteria

To be eligible, films need to qualify by meeting criteria in at least three of the below listed points (1.-6.)

1. Lead Character(s)

At least one of the lead characters are from underrepresented group(s). underrepresented relates to:

- gender/gender identity
- sexual orientation
- disability
- ethnicity
- skin color or people of color* (BIPOC)
- religion / belief
- socioeconomic and sociocultural background (reduced opportunities due to their level of income and/or education)
- non-mainstream (body weight, height)
- migration and displacement
